

EULA (End User License Agreement)

Your consent statement to the following agreement

It is recommended that you must install, use, and market the software after you read through all the terms and conditions of the software. You can avoid the terms and conditions if you have a separate agreement signed with the Recovee software.

In case you do not agree with any term and condition associated with this particular license of the software, it will be favorable that you do not install, download, use, and copy the software license.

The terms and conditions related to each license of the software demonstrate that how to use software and how it is limited to authorized users only. After purchasing a single copy of the license of Recovee OST to PST software, single use of the license is only permitted. On the other hand, when you purchase multiple copies of the license, you and your company are then permitted to use the number of copies which is clearly mentioned in the agreement of the license by Recovee software.

The scope of the license

We have created the software license in such a manner that it must not be used in a concerted manner. While in case of a single copy of the license, you being the single user is only allowed to use the software copy as per the agreement. Though multiple users are permitted to use OST to PST converter software with multiple copies of license, you make sure that the software is used one at a time not in a concurrent manner.

There may be some rights related to Recovee OST to PST converter which could not be expressly mentioned in the license, but that does not mean that it is not reserved by and to the Recovee software. Moreover, the software license agreement says that you are not permitted to change, alter, rent, reverse engineer, lease, disassemble, translate and decompile the license in any case. Adding to that, you cannot generate any kind of derivative works on the software. All these non-permissible acts cannot be performed in any manner by you and someone directed by you. The most importantly, you are not authorized to access or cannot allow others to access the OST to PST converter software which is available to other users in the compliance of a service provider to any application.

Under the agreement you make sure that to process data in the best quality, recovery program of the software needs a comprehensive testing with not so critical data and don't have any dependency on it.
